

LAKE LUNDGREN BIBLE CAMP ADVENTURE TRIP

Acknowledgement of Risk Assumption of Personal Responsibility Waiver and Release of Liability

I have chosen to voluntarily participate in a program conducted by Lake Lundgren Bible Camp and I acknowledge and understand the following:

1. Risks.

I understand that the Lake Lundgren Bible Camp program will be primarily conducted in the outdoors. It will operate in all kinds of weather, in a wide variety of physical settings, and with diverse people. As a result I further understand that during my participation I may be exposed to unusual risks, hazards, and stresses. Camp activities such as, but not limited to, wilderness water travel, road and woods biking, and backpacking are hazardous and may result in property damage or severe, maybe even fatal injury. Forces of nature such as darkness, heavy rain, lightning, strong wind, extremes of hot and cold, biting insects and animals may independently or in combination with my activities cause a serious accident. Stresses may also result from emotional anxiety, interpersonal conflicts, and homesickness. I acknowledge the risk inherent in wilderness activities and agree to assume that risk.

2. Assumption of Personal Responsibility

I agree that I am responsible for my safety while participating in the Lake Lundgren Bible Camp program and I am willing to assume that responsibility. This means that I agree to follow any instructions and directions given me by the Lake Lundgren Bible Camp staff, and will seek to act carefully and with good judgment at all times. I also agree to verify with my physician that I have no physical or psychological problems that would prohibit or limit my full involvement. I will submit a current medical exam and inform the Lake Lundgren Bible Camp staff in writing of any medical or emotional condition, which may restrict my safe participation in the program.

3. Waiver and Release

I understand the Lake Lundgren Bible Camp program to be a challenging experience with many diverse activities conducted in a wilderness camp environment. I am aware of the risks and am willing to assume them. Consequently, I waive, release and discharge any and all claims for damages of death, personal injury, or property loss, which I may have as a result of my participation in this program. I understand that these injuries and losses might result from the actions, lack of action, or carelessness of other participants as well as from my own actions. More specifically, I hereby hold Lake Lundgren Bible Camp, or the individual acting in an official or advisory capacity for Lake Lundgren Bible Camp, harmless and release Lake Lundgren Bible Camp and its agents from any liability and claims arising out of an accident or stressful incident during the program, except where caused by gross negligence by or wanton misconduct of the involved parties. I intend this waiver and release to also apply to any relatives, heirs, next of kin, personal representatives, or assigned who might pursue any legal action or claim on my behalf.

4. Insurance

I understand that all adventure trips by Lake Lundgren Bible Camp are NOT covered by any form of health insurance. Whenever I participate in such activities, regardless of where they are held, type or duration, I do so at my own risk and of my own free will. I am aware that I am responsible for paying all my own medical expenses and related costs for any injuries that may occur. In the event of professional rescue needed, the rescuer will bill the rescued person(s) for the costs incurred in the rescue. I hereby am advised to review my health insurance policies to determine for myself whether there may be any exceptions for this trip.

5. Responsibilities and Conditions

I further acknowledge that my failure to adhere to safety rules established by group leaders may result in my being asked to discontinue participation in the trip and its related activities. If I am barred from further participation in the activities, or if I voluntarily refrain from participation, or if I leave the trip, I am responsible for all expenses incurred and I have no claim for any refunds from Lake Lundgren Bible Camp, its officers, directors, employees or volunteers.
